**Age:** 8 weeks and older

**Temperament:** All pets must be non-aggressive to other dogs and or people.

**Vaccinations:** All pets must be up to date on Rabies, Distemper, and Bordetella

**\*if they are not current our on call vet will give vaccinations at owners expense.**

**Fees:** \$15 Full Day (more than 4 hours)

\$5 Half Day(4 hours or less)

**NO EXCEPTIONS**

**If it is over 4 hours (at all) you will be charged for a full day**

**If you do not sign in you will be charged for a full day of daycare**

**Hours: Monday-Friday 6:30am to 6:00pm**

**Saturday 7:30am to 1:00pm**

**\*If it's after closing hours, but an employee is still here (will not wait for customers from a phone call) you may pick up for an additional \$35 after hour fee, if able to pick up and is after six most likely systems have been closed out. If so payment must be made by cash or check.**

1. Owner understands and agrees that they are responsible for any harm caused by the Owner's dog(s) while attending daycare.
2. Owner understands that during normal dog play, Owners dog may be injured. All dog play is carefully monitored but scratches, punctures, tore ligaments, etc. may occur, despite our best supervision.
3. Owner understands and agrees that the Owner's dog is in good health, and up to date on all vaccinations, including a monthly preventative.
4. Owners understand it is owners responsibility to keep Deenies bed & biscuit updated on pets vaccinations, our systems do not give us reminders like the vets send reminders to the owners.
5. Owner further understands and agrees that neither Deenie's Bed & Biscuit nor its employees will be liable for any illness injury, deaths or escape of Owner's dog provided that reasonable care and precautions are followed.
6. Owner understands that even while vaccinated the owner's dog may contract kennel cough, and will not hold Deenie's Bed & Biscuit responsible.
7. Owner understands and agrees that the Owner's dog is required to be spayed/ neutered (after 6 months of age) to attend daycare.
8. Owner understands and agrees that Owner's dog will have access to a fenced outside area. Owner agrees to assume full liability if Owners dog escapes.
9. Owner understands and agrees that Owners dog will be picked up at or before closing time. If the owner's dog is not picked up 5 minutes after closing time, the owners dog will be boarded, and the owner will be charged for boarding.
10. Deenie's Bed & Biscuit reserves the right to refuse admittance to any dog that does not meet health and temperament requirements.
11. Deenie's Bed & Biscuit Owner understands that payment of charges incurred is due at the time of service unless other payment arrangements have been made. In the event that owner fails to make appropriate payment or arrangements to make such payment, owner understands that collection fees, attorney fees, and court cost will be owner's responsibility. Twelve percent interest will also be added to owners charged and will be owners responsibility.
